




The Market Surveillance Action for Tyres 2015 (MSTyr15) is a PROSAFE coordinated programme targeting C1 passenger car tyres for normal and extreme weather conditions. The main objective of this project is to help deliver the intended economic and environment benefits of the labelling of tyres with respect to improving fuel efficiency and other essential parameters by increasing the rates of compliance with the regulatory requirements.

## Are your tyres safe & energy efficient?





Fuel Consumption
Depending on its rolling resistance, the Fuel Efficiency Class of a tyre ranges from A to G. Tyres account for 20 to 30% of a vehicle's fuel consumption.




### Wet Grip

The Wet Grip rating tells how well the tyres perform in wet conditions on a scale from A to G. The difference in braking distances between each grade is roughly three metres.

## Market Surveillance Authorities have...



...checked 11.899 tyres labels. In more than 500 cases, the label was not compliant, not visible, or not available.



...reviewed 761 technical documentations.



...carried out laboratory tests for wet grip and rolling resistance of 134 different types of tyres. First analysis shows that more than 85% of the tyres tested were compliant.

### Stronger enforcement of the EU legislation

MSTyr15 intends to harmonise the enforcement measures taken by the Member States, and consequently, to increase market confidence, ensure safer road conditions, and improve consumer trust.

Data collection has been synchronized with a customized database in order to make information immediately available in all participating countries and to avoid double sampling.

### Good Practice Guidelines

The participating authorities of MSTyr15 have set up Good Practice Guidelines, common procedures for exchanging information, trainings for the inspectors and national workshops.
